Please Read Carefully

1. Indian Tribal License Plates are not transferable from one owner to another. Only one license plate per vehicle will be issued.
2. Indian Tribal License Plates may be transferred to another vehicle owned by and registered in the name of the same tribe to whom the license plate was issued, provided application for transferring such license plate is made to the Oklahoma Tax Commission.
3. The Indian Tribal License Plate is to be displayed on the rear of the vehicle for which it is issued.
